The following rates of water and sewerage tariff have been approved by Authority of PUDA in its 22nd meeting held on 01-09-2017 vide agenda item No. 22.13 and shall applicable in area under its jurisdiction of PUDA and its all authorities with effect from 1st of sept-2017;

Important Notes:-

- 1 In case of stoppage or faulty meter, average of last three bills will be charged for two months & In case the consumer does not set right the meter with in two months at his own cost, double the average will be charged beyond two months which will be non-refundable & non-adjustable.
- 2 A Consumer who fails to pay the water charges by due date shall liable to pay penalty @ 10% of the Amount of water charges due from the consumer.
- 3 All the charges shall be automatically hiked by 5% on the first day of every financial year for items no 1,2,3,9,10,12
- 4 The consumer will be charged double the normal rates described above, for installation of tubewell without approval of the competent authority for the period from the date of installation of the tubewell till the approval is obtained in this behalf.
